1. GENERAL DESCRIPTION OF THE PROJECT

This project comprises over 150 hours of oral history interviews by 58 influential Arizonans honored by the Historical League, Inc. These are the personal recollections of those who shaped the cultural fabric of Arizona by their contributions to the arts, business, education, entertainment and sports, politics, philanthropy and community service. Arizona, at its Centennial, is reflected through the lens of their lives and achievements.

The Historical League, Inc. will produce an Arizona Centennial Video *IN OUR OWN WORDS* Reflections and Recollections of Arizona Historymakers™ based on these interviews in which each individual tells his/her own story which has made a significant impact on the history of Arizona.

Complete transcripts of all oral histories will be made available on the Historical League, Inc.'s website historicalleague.org as these personal narratives are now only available by appointment at the Arizona Historical Society Museum in Papago Park.

2. LEGACY PROJECT CRITERIA

Accurately portray a significant aspect of Arizona History.

These oral histories, told by Historymakers™, relate important events--whether large or small-- in their lives, the contributions they made, challenges faced, and impact and influence they have had on our state, all of which combine to chronicle the history of Arizona and, importantly, make predictions for its future.

Be accessible to large numbers of visitors and users.

Complete Historymakers'™ transcripts will be available on-line at historicalleague.com and arizonahistoricalandsociety.org for the benefit of students, teachers, historians, researchers and the general public. Links to complementary websites are encouraged.

Demonstrate collaboration in the planning

Collaborators include the Historical League, Inc. membership, the Arizona Historical Society, Agave Productions, and living Historymakers™.

Produce an enduring product that will live on after 2012

The underlying goal of the entire project is one of longevity. Transcripts and the video will be continuously available. The permanent Historymakers™ exhibition at the AHS Museum in Papago Park will show photographs, memorabilia, and personal objects belonging to selected Historymakers™ on a rotating basis. Future Historymakers™ will be identified and recorded and added to the corpus of materials already accumulated.

Educational components

Historymakers™ videos and transcripts are appropriate for classroom instruction at lower and upper grade levels as well as academic researchers. Teachers will find them an excellent supplement to the 4th grade text, *The Arizona Story* (adopted by many school districts and a designated Legacy Project). Widespread accessibility facilitates use by multiple student audiences.

A plan for implementation

Transfer of oral histories to the Historical League, Inc. website is currently underway. This process requires from 3 to 6 hours/volunteer time per individual history. Agave Productions is editing and producing the Historymakers™ Centennial video. The Historical League, Inc. membership is committed to fundraising in support of this effort.
